5. CH/15/0464 – PROPOSED WORKS TO FOOTBRIDGE AT RUGELEY TOWN STATION PART 18 GPDO PRIOR APPROVAL REQUEST

The Committee noted a proposal from Network Rail to modify existing parapets of the footbridge at Rugeley Town Station.

Members made reference to the inconvenience being caused to passengers from pools of water on the footbridge. This became a major risk in very cold weather when ice formed, causing a real hazard for pedestrians.
